Property tax exemptions would allow homeowners to exclude the value of a solar panel system from the value of their property for tax reasons. 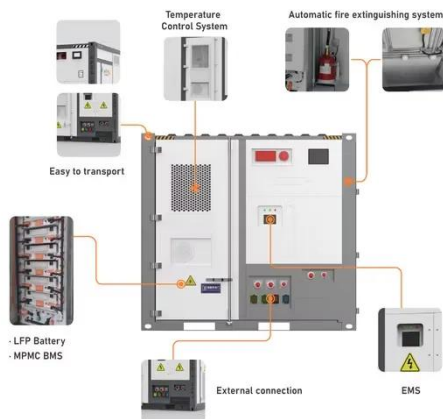
