Starting 1 April 2026, value-added tax (VAT) export rebates for photovoltaic (PV) products and certain other categories will be abolished. On 9 January 2026, China's Ministry of Finance announced a significant adjustment to its export tax rebate policy. The announcement, jointly issued by the Ministry of Finance and the State Taxation Administration, said that export tax rebates for the value added tax of. China will scrap value-added tax export rebates for PV products from Ap, while cutting battery rebates ahead of a full phaseout, raising export costs for manufacturers and potentially pulling shipments forward into early 2026. For example, aluminum processors currently earn 27,709 yuan per metric ton, including a 13% tax rebate of 2,859 yuan.
