Japan's feed-in tariffs (FITs) for this year will range from JPY 9.06/kWh to JPY 16/kWh, depending on system size. The Japanese government also says it will hold four more auctions for solar projects above 250 kW this year. Japan's Ministry of Economy, Trade and Industry (METI) has published.
