Lebanon s tariffs on imported solar inverters



Overview

To promote clean energy adoption, the Lebanese Customs Administration has declared a temporary exemption from both value-added tax (VAT) and customs duty on devices and equipment designed solely to harness solar and other clean energy sources for electricity generation. The key to understanding the opportunity lies in the specific Harmonized System (HS) codes and their associated tariffs: Imported Finished Solar Panels (HS Code 8541. 40): These are subject to a 5% customs duty. For every one million dollars of panels imported, the tariff cost is \$50,000. With minor exceptions, European goods are exempted from customs fees in. The Tariff & Trade Data platform provides official tariff and import data for more than 150 economies, including annual data from 1996 onwards for many of them. It aggregates and disseminates official information about applied tariffs and import data notified by WTO Members in the WTO's Integrated. How much does solar energy cost in Lebanon?
