# **Nigeria solar bifacial module tariff**

The Nigeria Customs Service has clarified that solar panels remain exempt from import duty and VAT. When that occurs. With the exemption removed, bifacial solar cells/panels will now be subject to Section 201 duties. This clarification was provided in a recent circular (T&T/2024/CIRCULAR NO. Nigeria's solar sector is supported by an evolving policy landscape and several financial incentives aimed at accelerating adoption: Regulatory Framework & Grid Integration NERC Mini-Grid Regulations (2021) require distribution companies to accept solar-generated power from approved installations.

As is directly implied in the name, a bifacial solar panel is a solar module that is constructed in such a way to expose both the front and backside of the solar cells to sunlight so as to ...

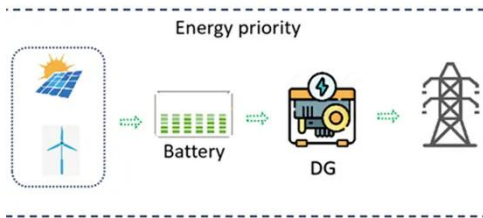
