Lodging An Export Declaration
Amending An Export Declaration
Withdrawing An Export Declaration
Confirming Exporter Status
An Export Declaration can be lodged either:
1. electronically through the Integrated Cargo System (ICS) 2. at one of our counters using the Export Declaration (B957 Form), and, if required, the Export Declaration Supplementary page (B957a Form).
