Shares of solar stocks, including rooftop solar provider Sunrun(NASDAQ: RUN), renewables-focused utility NextEra Energy(NYSE: NEE), and renewable power provider AES Corp. (NYSE: AES), plunged on Thursday, falling 40%, 9. 2%, respectively, as of 12:50 p. 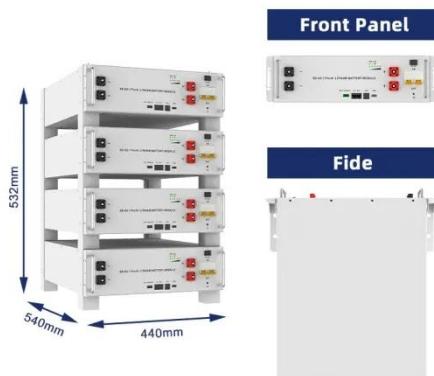
